We desire to offer the care-givers, the working class, and the routine clients a luxury experience that allows them to feel empowered, beautiful and seen. site. ## Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Mailing address
- Email address
- Phone number

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ### **Sharing Information with Third Parties**

The Company does not sell, rent, or lease its customer lists to third parties.
